DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Dilday Mill is a water-powered, grist mill standing two stories above ground level and three stories above Turnback Creek. Nearly half of the rectangular-plan mill extends over the water. A storage bin is attached to the northwest corner.

EXTERIOR

Over-all dimensions

The mill measures approximately 22' by 34'.

Construction materials and colors

Bevel lap siding sheaths a wood frame. Corrugated tin covers the original roof of hand-split cedar shingles. Poured cement and rubble stone form the north and east and west walls of the forebay respectively; the south side is open.

Openings

Windows. All windows have been stripped of their sash. Openings are positioned as follows:

- 1) front (west) elevation - one window to each side of the centrally placed entrance on the first story and one window in the gable over the doorway
- 2) headrace elevation - four windows evenly spaced across on the first story and two windows above the first and third windows of the first story counting from the rear (east) elevation on the third story
- 3) rear (east) elevation - two windows evenly spaced across the first story and one window centered in the gable
- 4) tailrace elevation - three windows spaced in the same manner as those of the opposing headrace elevation on first story and two windows above the first and third windows counting from the rear (east) elevation on the third story.

Doorways. Three doorways provide access to the interior of the mill: one at basement level on the headrace elevation, one centered on the first-story of the front (west) elevation and one off-center to the north on the basement level on the rear (east) elevation. A fourth entrance is on the first-story, south wall of the storage bin.

All doors are gone.

Porch

A wood porch spans a portion of the front (west) elevation approximately 36 inches above ground level. Its shed roof of corrugated tin over a wood frame

has collapsed. A flight of wood steps is at the south end.

Storage bin

A one-story, L-shaped, wood-frame storage bin is attached to the northwest corner of the mill at the first-story level; wood poles support the structure. Rectangular openings are on the west side. Exterior access is by an entrance on the south wall from the porch. A gable roof of corrugated tin over a wood frame covers the storage bin.

Roof

A gable roof covers the mill.

Other details

A poured concrete fish ladder runs across the rear (east) elevation at water level. A concrete basement landing on the headrace elevation is reached by a flight of concrete steps attached to and parallel to the wall.

INTERIOR

Remaining milling equipment includes elevator belting, grain bins, a cyclone blower, and various pieces of screening and cleaning devices.

Forebay

The walls of the forebay are of rubble stone (east and west) and poured concrete (north); the floor is concrete.

Basement

A wood floor, now collapsed, was over the forebay; a dirt floor is in the west half.

First floor

Horizontal, tongue-and-groove, wood boards cover the walls of the two rooms of the first floor. Flooring is of four-inch and six-inch, tongue-and-groove, yellow pine. Flour bins are along the south and west walls of the east room.

Second floor

The second floor is comprised of a single room. There is no finish on the walls; floors are of four and six-inch wide, tongue-and-groove, yellow pine. The cyclone blower is intact.

A steep stairway in the southeast corner provides access to the third-story loft area.

Storage bin

Only the sides of the two bins remain.

ALTERATIONS

The storage bins at the northwest corner were added in 1925;¹ a wood shed (now gone with the exception of its poured concrete foundation) to house a second turbine at the forebay level and a marine privy and turbine shaft on the first floor dates from 1922.² The fish ladder is of 1925³ vintage. A concrete block well house, located approximately 12 feet west of the mill, was added in ca. 1950's.⁴ The auxiliary gasoline engine sat on a concrete pad (date unknown) east of the storage bin.

Those features lost through deterioration and/or vandalism include:

- 1) a board walk with handrail attached to the headrace elevation at the basement level and extending over the water to provide access to the forebay draw gates
- 2) the wood draw gates of the forebay
- 3) a series of rods parallel to the headrace elevation for straining the water
- 4) an L-shaped stairway connecting the basement, first, and second floors
- 5) the bottoms (or floors) of the storage bins
- 6) the barn sash from each window
- 7) doors from all entrances
- 8) the wood flooring of the basement which has collapsed into the forebay below
- 9) all milling equipment unless noted above
- 10) a red brick chimney to service a heating stove in the southwest corner.⁵

CONDITION

Dilday Mill is in deteriorated condition. The southwest corner of the building is collapsing; much of the wood siding is gone. All windows have been stripped of their sash; no doors remain to fill the entranceways. The basement floor over

the forebay has collapsed as has the roof of the front (west)-elevation porch.

PRESENT STATUS

The Missouri Department of Conservation is interested in the acquisition of property lying east of Turnback Creek for development and use as a possible stream access site. The development would provide for road access, parking, small boat launching, and sanitation.⁶

The owner of the mill is willing to donate the mill and an acre of land to any group or organization who can provide a suitable plan for the mill's preservation and perpetual care. Enrollment on the National Register should provide impetus to the development of such a plan.

SITE

Dilday Mill is located on the west bank of Turnback Creek, just south of County Route K in Dade County, Missouri. Situated on a slight rise, fairly level ground stretches south of the mill; the creek bank rises into a precipitous limestone ledge which runs for two miles down the creek 40 to 50 feet above the water. A heavy growth of trees (oak, hickory, walnut, and hackberry) is found on both sides of the creek, becoming so thick in places as to form a canopy across the water.

West of the mill is what remains of the village of Turnback, Missouri. Most surviving buildings are not contemporary with the mill: a wood-frame miller's cottage (1918), native stone chicken house and boat storage shed, and the Earl Kissee Cabin (1938). The general store and post office are gone; only the ruins remain of the Scott Home. Remaining residential buildings include the Z. T. Mitchell House with barn and smokehouse (1874, poor condition) and the Hamlett House (unknown date, altered).⁸

STATEMENT OF SIGNIFICANCE

Dilday Mill on the Turnback Creek, southeast of South Greenfield, Missouri, is significant as the oldest of three water-powered mills still in existence in Dade County. During its period of operation, the mill was a social/business center of the village of Turnback, Missouri.

When the first settlers came to Dade County (as early as 1833 and 1834),¹ they sought sites for settlement locations near the many streams and rivers; and at least ten mills were known to have been built along the principal waterways (the Sac River and Turnback and Limestone creeks).² Of these mills, today only three are standing: one in operation (Hulston Mill [1880]), moved from its original location) and two in deteriorated condition (Comet [1882] and Dilday [1867] mills).³

History

The original mill was built in 1840⁴ by Britton Finley; companion buildings included a saw mill and blacksmith shop. Following the formation of South Township in February, 1860,⁵ Finley's Mill was designated as the place to hold elections.⁶ The building was burned during the Civil War.⁷

In September, 1867,⁸ John B. Dilday came from Kansas, buying the three-quarter section on which the present mill is located. On Christmas Day of that year,⁹ Dilday, with the help of his neighbors, raised the frame for a new mill. Frequently changing owners, the mill stayed in operation until 1943.¹⁰ In the late 1950's the flour rollers and 42-inch stone buhrs were sold; its turbine-type water wheel was bought by a junk dealer.¹¹

In its heyday, Dilday Mill was the center of the busy village of Turnback. A post office was located there as early as 1856 and continued until 1905, when it was discontinued by reason of R.F.D.¹² The postmaster was John B. Dilday, who served in that capacity from 1869 until his death in 1895 except for three months during 1883.¹³ Although numbering only 35 in population, the community of Turnback did boast of a blacksmith (Jackson Brisco), farmers (Jasper Dilday and Z. T. Mitchell), a mill operator (John B. Dilday), and a general store (Potter & Zellweger) in 1879. Wheat, dry hides, feathers, and fruit were shipped to Ash Grove for distribution. A Christian church and a district school were in the vicinity.¹⁴ In 1883, a physician (R. M. Irwin) had joined the community; J. J. Booker was the blacksmith and A. Zellweger ran the general store. Shipments to Watkins (or South Greenfield) included wool, wheat, potatoes, and livestock.¹⁵ By 1889, busi-

ness directories listed only a physician (T. M. Bryant), a mill operator (John B. Dilday), and a blacksmith (Kerr Hastings); the population had dwindled to 18. M. D. Grootemoat was listed as the mill operator in 1898; M. D. Shockley ran the general store.¹⁷

The survey of Missouri's historic sites is based on the selection of sites as they relate to theme studies in Missouri history as outlined in "Missouri's State Historic Preservation Plan." Dilday Mill is, therefore, being nominated to the National Register of Historic Places as an example of the themes of "Exploration and Settlement," "Economics," "Society," and "Technology."

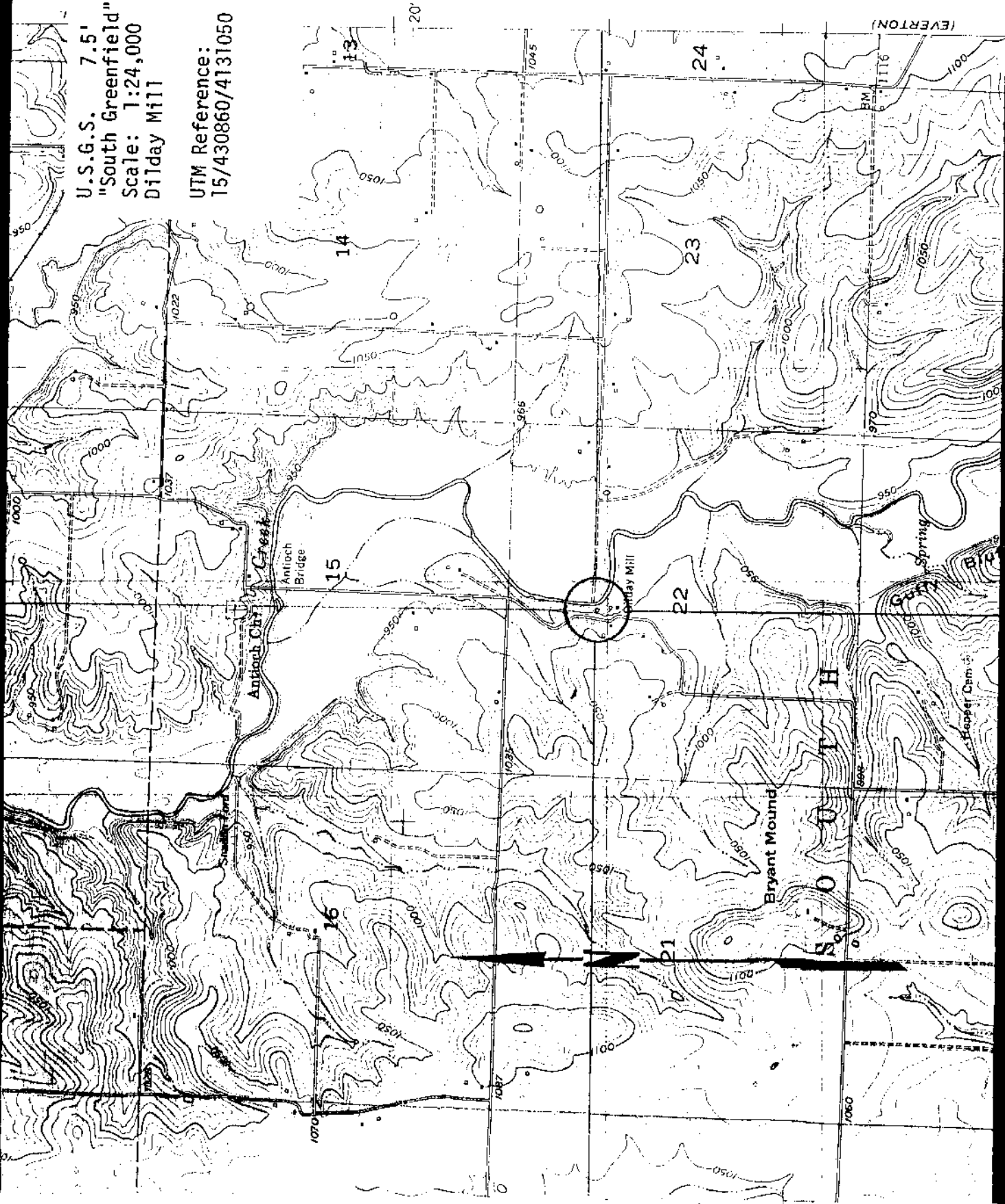

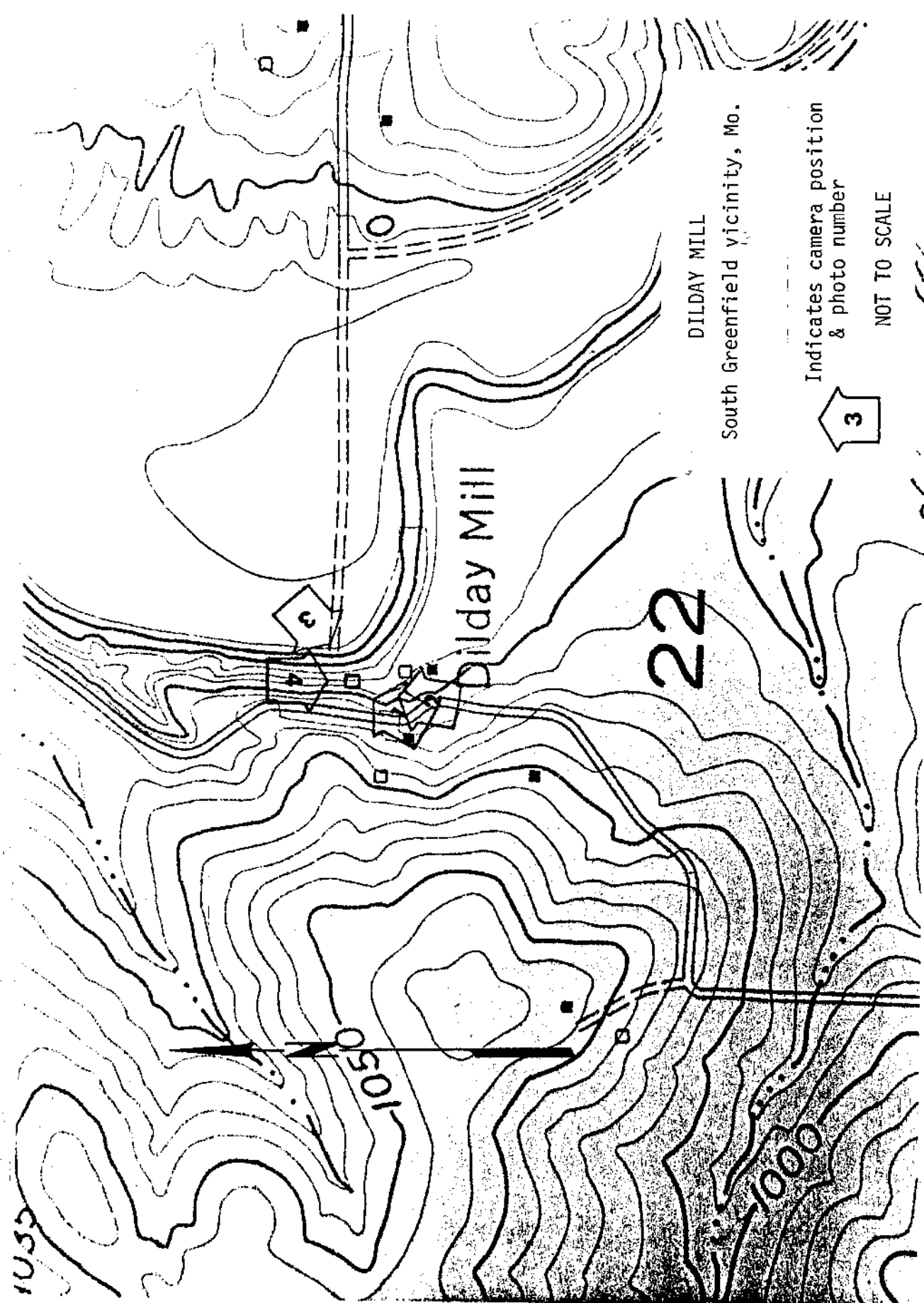

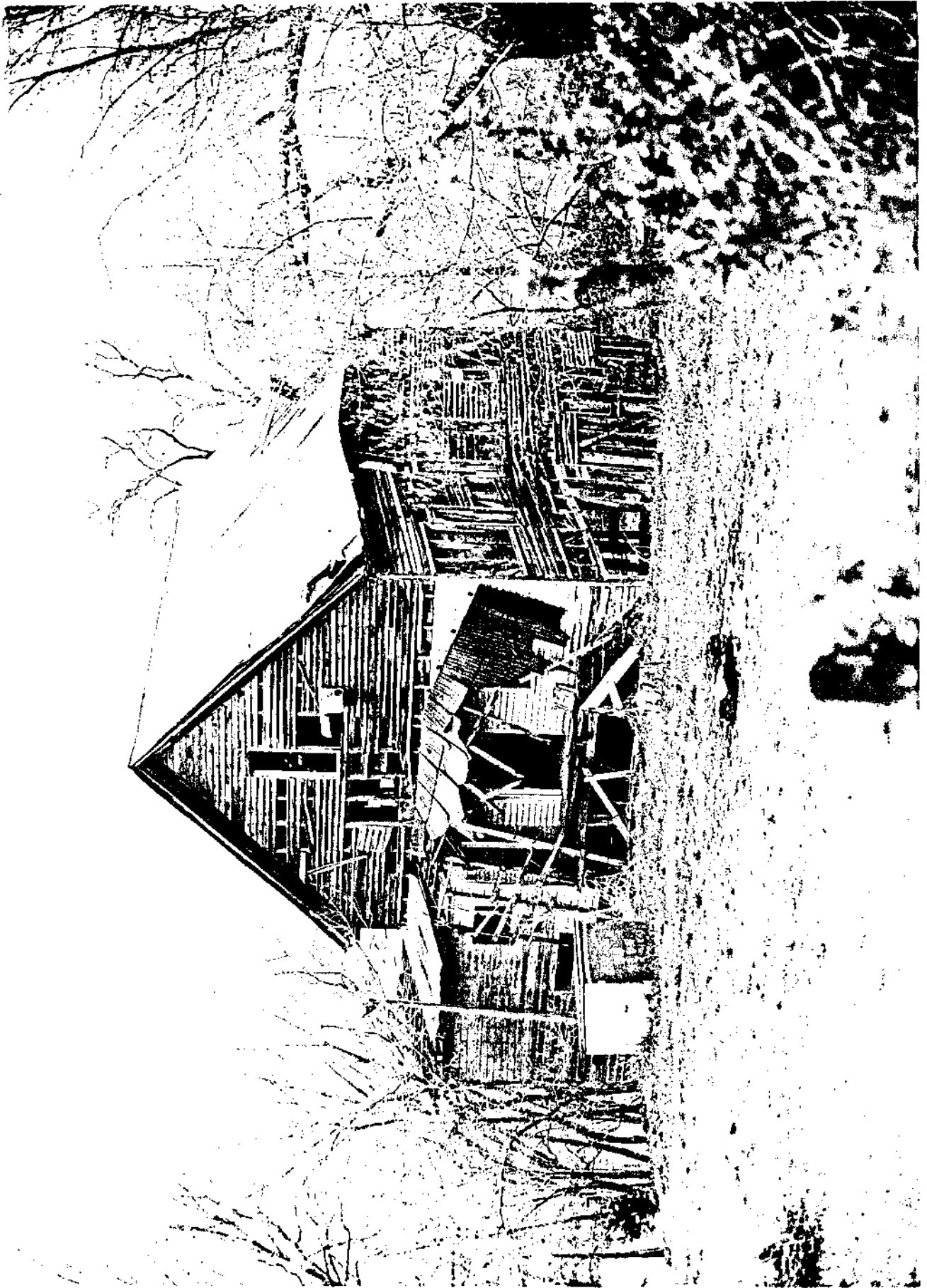

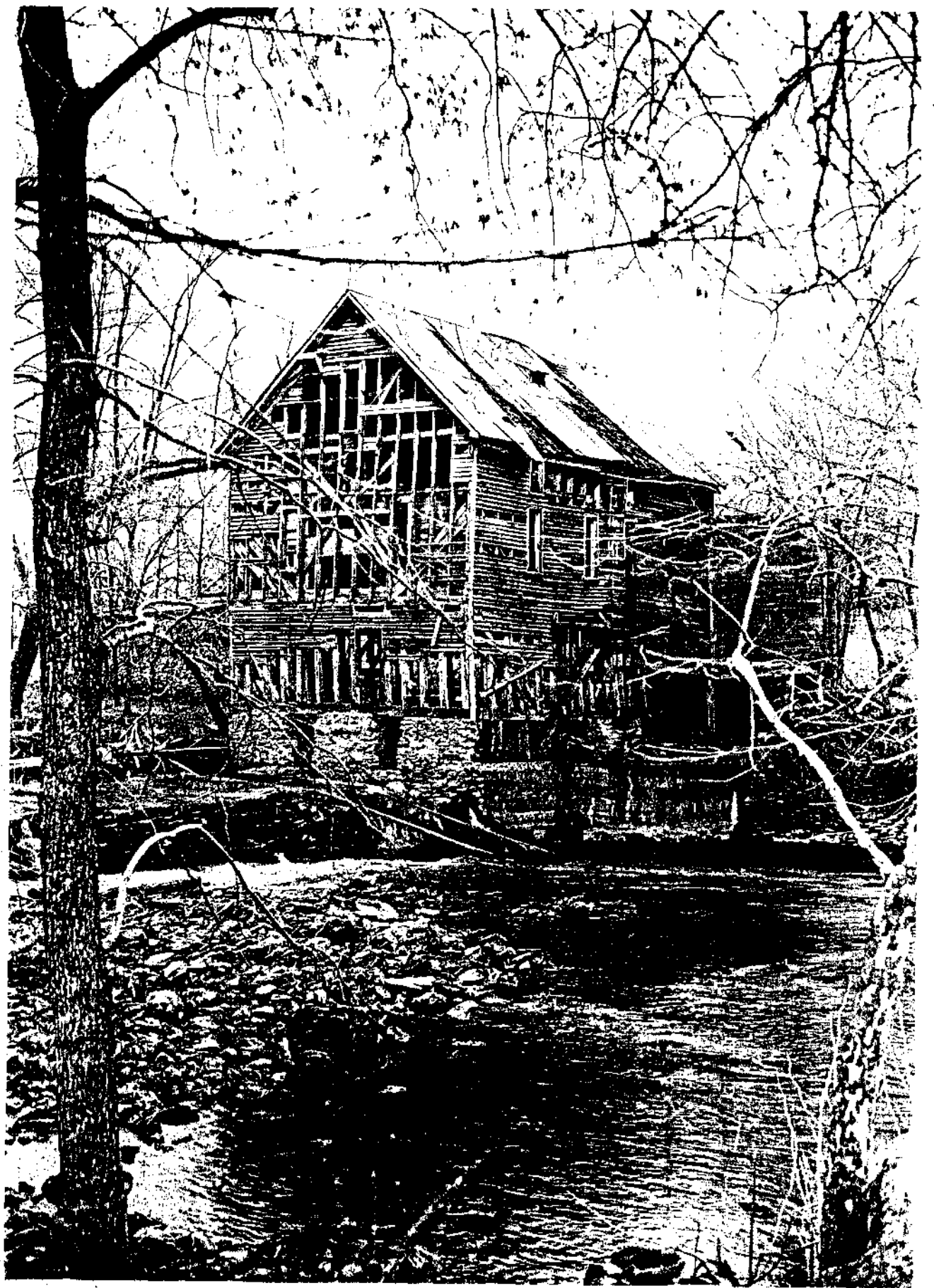

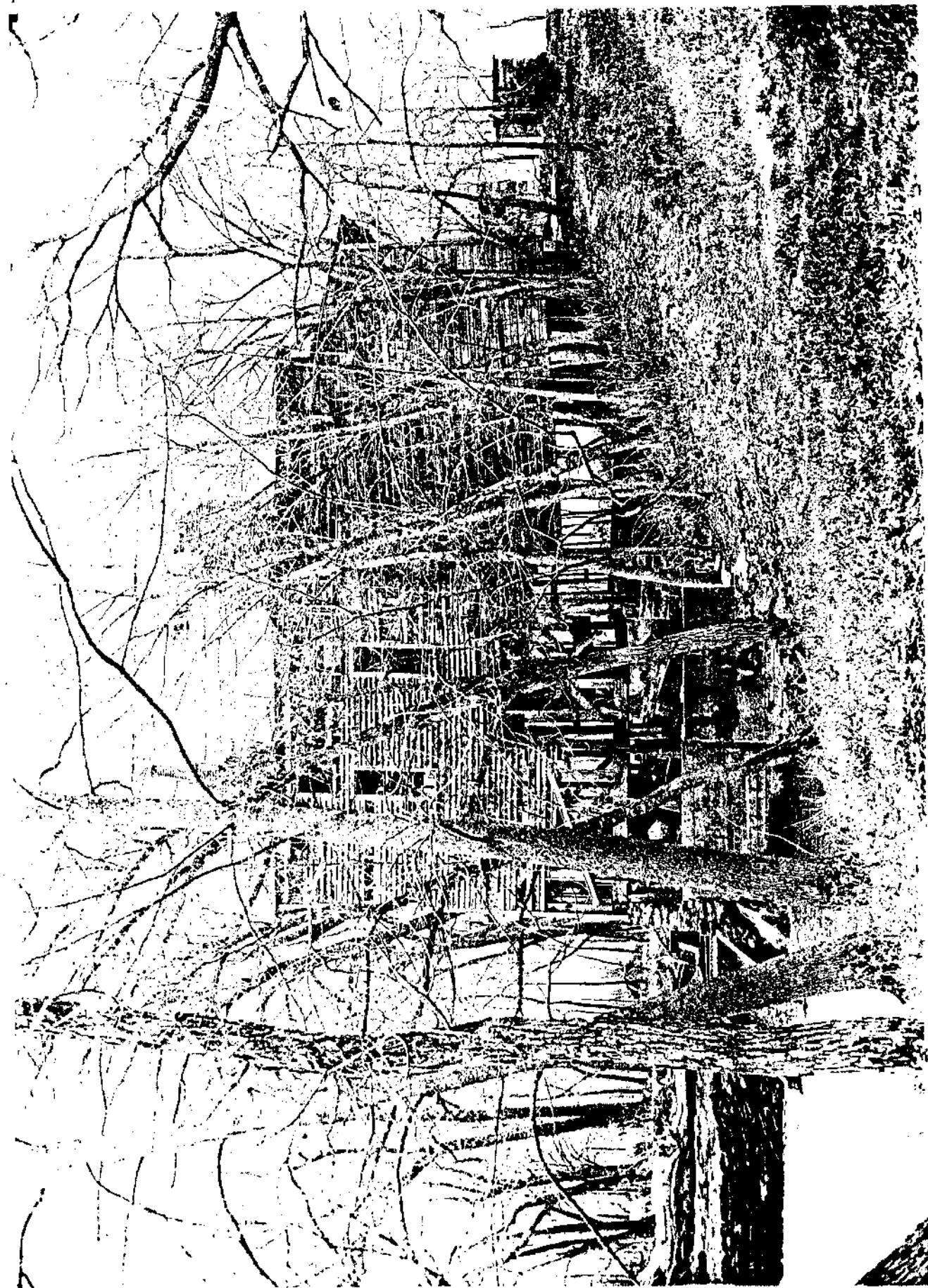

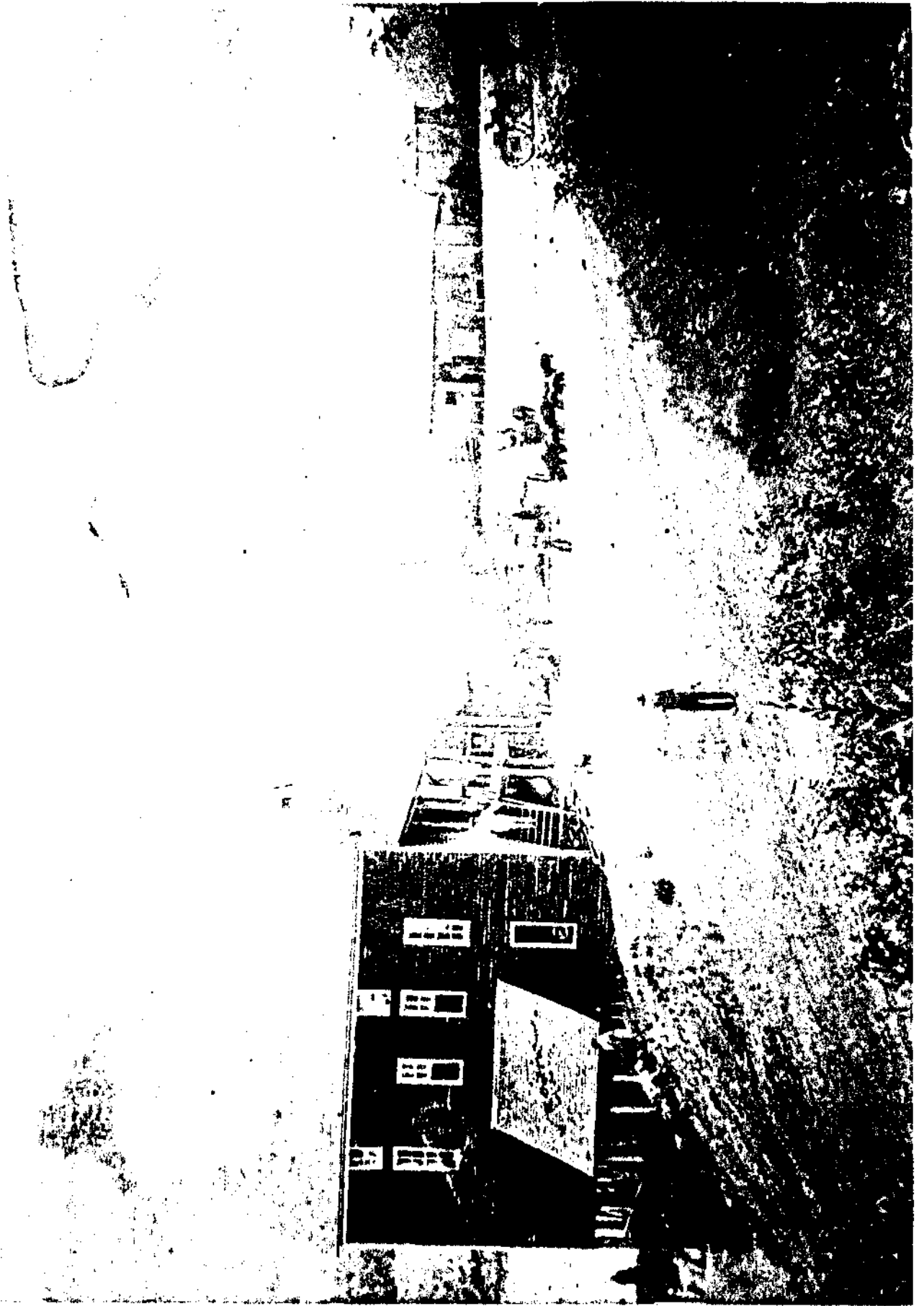
